## BAC Resolution No. 2019-01-001B

A BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT VIA COMPETETIVE BIDDING TO 3R'S BUILDERS & RESOURCES FOR THE PROCUREMENT OF REPAIR AND REHABILITATION OF PERSHING TAN QUESTO ES AND GUINGONA ES

WHEREAS, the Department of Education (DepEd), Division of Ozamiz City prepared the Terms of Reference (TOR) and Invitation to Bid (ITB) relative to the procurement of Repair and Rehabilitation of PT Queto ES and Guingona ES with an Approved Budget for the Contract (ABC) of Two Million Seven Hundred Twenty-Three Thousand Seven Hundred Eighty-Two Pesos and 07/100 (Php 2,723,782.07);

WHEREAS, on 24 October 2018, the DepEd, Division of Ozamiz City Bids and Awards Committee invited all interested bidders to participate in the competitive bidding for the procurement project through posting of the ITB at the PhilGEPS website and in the three (3) conspicuous places of the Division Office of DepEd, Division of Ozamiz City for seven (7) calendar days;

WHEREAS, in response to ITB, only one bidder – DDS Builders submitted bid proposal during the bid opening at the BAC Office on November 20, 2019; 9:00 AM;

WHEREAS, upon evaluation, the Bids and Awards Committee found the eligibility requirements submitted by DDS Builders as "Complying", thus its financial proposal was opened;

WHEREAS, per post-evaluation, the bid proposal of DDS Builders amounting to *Two Million Seven Hundred Sixteen Thousand Ten Pesos and 22/100 (Php 2,716,010.22)*, inclusive of appropriate taxes and fees, is within the ABC;

WHEREAS, per post-qualification evaluation conducted by the DepEd, Division of Ozamiz City BAC, Secretariat and Technical Working Group, found DDS Builders compliant with the requirements of DepEd, Division of Ozamiz City and the law of the said procurement project; hence; declared its bid as the single calculated and responsive bid;

WHEREAS, Section 12 of RA 9184 mandates that the Bids and Awards Committee (BAC) shall recommend the award of contract to the Head of the Procuring Entity or his duly authorized representative;

NOW, THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED that a Resolution to Award of Contract via competitive bidding to DDS Builders amounting to *Two Million Seven Hundred Sixteen Thousand Ten Pesos and 22/100 (Php 2,716,010.22)*, inclusive of appropriate taxes and fees be APPROVED.
