INVITATION TO BID FOR SUPPLY AND DELIVERY OF SCHOOL FURNITURE CY 2016 BATCH 1

- 1. The *DepED*, *Division of Ozamiz City*, through the *Sub-Allotment Release Order No. BMB-B-16-0000748 dated February 10*, 2016 intends to apply the sum of *Php 1,745,500.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply and Delivery of School Furniture CY 2016 Batch 1 from Basic Educational Facilities Fund.*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *DepED*, *Division of Ozamiz City* now invites bids for 225 *ES/JHS Armchair*(45/CL); 5 *ES/JHS TTC* (set); 1,960 pcs Secondary Armchair (40/CL); and 49 sets Teacher's Table and Chair Set to be delivered to 1(one) elementaryand 5(five) Secondary Schools in the Division of Ozamiz City. Delivery of the Goods is required *Ninety* (90) calendar days. Bidders should have completed, within *Five* (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from *BAC Secretariat*, *DepED*, *Division of Ozamiz City* and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m. Monday to Friday.
 - A complete set of Bidding Documents may be purchased by interested Bidders on *August 1, 2016 to August 8, 2016 at 1:29 p.m.* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos Only (Php 5,000.00)*.

- 5. The *DepED*, *Division of Ozamiz City* will hold a Pre-Bid Conference on *August 5*, 2016 @ 1:30 p.m. at *Division Multi-Purpose Hall*, *Division of Ozamiz City*, *IBJT Compound*, *Carangan*, *Ozamiz City*, which shall be open to all interested parties.
- 6. Bids must be delivered to the address below on or before *August 18, 2016 @ 1:29 p.m.*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *August 18*, 2016 @ 1:30 a.m. at *Division Multi-Purpose Hall*, *Division of Ozamiz City*, *IBJT Compound*, *Carangan*, *Ozamiz City*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. All plastic will be used for armchairs and all wood for *Teacher's table & chair*.
- 8. Wood to use for the Teacher's table & chair must be Gemelina, Red Lauan, Tanguile or combination of the three.
- 9. The *DepED*, *Division of Ozamiz City* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
