CORRIGENDUM AND ADDENDUM TO REGION MEMORANDUM NO. 59, S. 2017
(Policy on the Conduct of the End of the School Year Rites)

To: Schools Division Superintendents
Private Elementary and Secondary School Heads
All Others Concerned
This Region

1. With the issuance of DepEd Order No. 8, s. 2017 entitled *School Year 2016-2017 End of School Year Rites* and the strong clamor of some parents of graduating students, the following modification is hereby adopted to Paragraph 2.d. of the issued Region Memorandum No. 59, s. 2017, to wit:

"d. *Wearing of school uniform during the graduation ceremony is encouraged to avoid unnecessary expenses. The wearing of toga is allowed only upon the instance of the majority of the graduating learners in consultation with the parents called for this purpose. However, the non-wearing of toga shall not preclude a student from joining the graduation rites or moving-up ceremony.*"

2. As likewise expressly provided in the cited Order, the ceremonies shall focus on the theme *Sabay-Sabay Na Hakbang Tungo sa Maunlad na Kinabukasan* to highlight on the importance of the concerted endeavor and collaborative efforts of the stakeholders and learners in forging a better and progressive future for the Filipino youth.

3. All other provisions stated in the said Memorandum still remain in effect.

4. Immediate dissemination of this Memorandum is desired.
